DESCRIPTION

• concentrated dye-based tinters for the preparation use in Craftsman FRS dye based interior stains

PRINCIPAL CHARACTERISTICS

- when mixed with relevant stain bases, provides timber stains with good resistance to grain-raising and fading
- allows tinting of stains of varying concentration and tones, through different dye levels
- good penetrating properties and excellent clarity to enhance grain features
- final mixed stains can be used in spray and/or hand application
- ideal for timber applications such as interior furniture, kitchen cupboards, blinds and shutters
- colour formulations are available from the Wattyl Colour Studio

Note: We advise that you test this product to determine if it is suitable for your particular use.

Universal Dye Concentrates must be mixed with a stain base before use, in order to achieve an even finish. Not for use without mixing.

INSTRUCTIONS FOR USE

- usage level: Universal Dye concentrates account for approximately 6% (60 ml per 1 litre) of the final stain formulation. Higher levels, up to a maximum of 20% (200ml per 1 litre) may be used where higher concentration tone is required
- levels lower than 6% will achieve lighter, more subtle tones
- dye concentrates must be used with specific Wattyl Craftsman Dye bases to make a dye stain product. Refer to the appropriate technical data sheet.
- weigh out the Universal Dye Concentrates into a container according to the stain formulation
- under stirring add the Universal Dye Concentrates to most of the Wattyl stain base
- use the remaining stain base to wash out the dye concentrate residue from the container into the batch, whilst stirring. Stir for 5-10 minutes
- shelf life (cool, dry place) at least 12 months in unopened container
- for recommendations outside those contained on this data sheet, refer to Wattyl
