DESCRIPTION

SURFACE PREPARATION

- all surfaces must be free from wax, silicone, oil and other contaminants
- fill holes and minor imperfections with Wattyl Full Stop Timber Putty
- sand smooth with 180-240 grade fre-cut paper, and remove all sanding dust

INSTRUCTIONS FOR USE

- agitate thoroughly with a flat-bladed stirrer before and during use
- strong colours, thinning not required
- lighter tones, thin up to 50% with Thinner L748
- spray and wipe applications, thin up to 20% with Thinner L748

 Note: Use of retarder thinner may leave the stain wet for longer periods.
- apply by conventional, air-assisted or airless spray, dipping, wiping or by a wet-spraying and wiping
 process. If spraying, apply coats passing the gun briskly over the surface and lapping each pass of
 the gun on wide surfaces in the normal manner. For a uniform finish, always rub lightly along the
 grain with a clean cloth pad while the stain is still wet
- remove excess stain to prevent colour variation. Wiping may be difficult in hot environments because of the "fast" solvents used in this product
- seal and topcoat with a suitable Wattyl system
 Warning: Excessive builds on timber can lead to stress-cracking as the timber adjusts to its new conditions of temperature and moisture content. The recommended maximum total build is 150 microns (dry film) for the total system.
