# INSTRUCTIONS FOR USE

- add up to 500mL of Dry Add to 4 litres of unthinned enamel, do not add more than the recommended amount
- Dry Add is moisture sensitive. Part cans must be resealed firmly and used within 48 hours
- pot life at 25°C 8 hours for Agricultural Enamel and All Purpose Enamel, 4 hours for Duranamel BR22
- do not use after this time even if the mix is still liquid
- stir the components and mixed product well using a mechanical mixer
- freshly catalysed material should not be added to product that has been catalysed for some time
- any film cured with Dry Add must be thoroughly abraded prior to overcoating
- shelf life (cool, dry place) at least 12 months in unopened container

- flammable. Avoid contact with heat and naked flame
- avoid contact with skin and eyes
- use gloves, mask and goggles during application
- provide adequate ventilation when using in confined spaces
